### Purchaser Rights

This cat/kitten is guaranteed to be in good health at the time of sale and has been inoculated for panleukopenia, rhinotracheitis, and calici virus. Kittens also require a rabies vaccination at the age of 16 weeks at the Purchaser's expense. Kittens have been treated with Pyrantel or Panacur wormer. Adult cats will be up to date on FVRCP and Rabies inoculations at the time of adoption. This health guarantee extends **72 hours**. During this time, the Purchaser should have the cat/kitten examined by a licensed veterinarian and have him/her perform any tests deemed necessary to assess health at the Purchaser's expense. If the Purchaser's veterinarian renders a diagnosis of ill health (must be accompanied by a clear written statement of the veterinarian's findings and/or diagnosis, including the clinical basis for them, and copies of all relevant reports and tests, along with an estimate for treatment), the breeder reserves the right to have the cat/kitten taken to the breeder's choice of veterinarian for a second opinion, at which time the breeder will pay all reasonable testing/treatment costs. Purchaser may also decide to return the cat/kitten in exchange for another cat/kitten of similar quality, selected by the breeder. If a veterinarian or Purchaser initiates any treatments or vaccinations during this time period without the breeder's written consent, this health agreement is null and void.

The Breeder warrants that the kitten is genetically sound and will replace the kitten with another of similar quality if the kitten dies of a congenital defect before **3 years of age** and that said defect is evidenced in a necropsy report presented to the Breeder. **No refunds.**

The Breeder will provide a complete health record at the time of purchase.

The Breeder will provide a CFA/TICA Blue Registration form for kitten **or** a CFA/TICA registration slip for a cat **and** a four-generation pedigree.

### Purchaser Responsibilities

Purchaser agrees that adequate indoor sanitary facilities will be provided and that this cat/kitten will receive proper veterinary care and will receive annual well visits and inoculations as recommended by their veterinarian. Purchaser agrees to provide companionship for this kitten, never leaving it alone for long periods of time without human attention. Purchaser agrees that the kitten will receive generous amounts of exercise and be provided with toys. Purchaser agrees to keep the cat as long as it lives, unless extreme circumstances intervene. The Breeder will make provision for care of the cat if the Purchaser should die or otherwise become unable to care for it. Such provision does not include euthanasia. If purchased as a **pet only**, the Purchaser agrees to **neuter/spay** this cat between 5 and 7 months old (no sooner). **This cat/kitten will not be declawed. This cat/kitten will not be allowed to roam outdoors. This cat/kitten will not be allowed to play in or around the clothes dryer or washing machine.**
